Climate Smart Commodities Payment

PRACTICE	COMPENSATION	REQUIREMENTS
Cover Crop - New in 2023	\$25/acre	Must provide FSA documents and FSA subsidiary print and will be shared with NRCS/USDA. Cannot be paid for cover crop on the same acres by federally funded programs like EQIP/CSP/RCP. Has to be new practice or expanded practice. Must have wheat, soybeans, or canola in rotation.
Cover Crop - New in 2018 to 2022	\$15/acre	Must provide FSA documents and FSA subsidiary print and will be shared with NRCS/USDA. Cannot be paid for cover crop on the same acres by federally funded programs like EQIP/CSP/RCP. Acres could not have cover crop prior to 2018. Must have wheat, soybeans, or canola in rotation.

Standard Practice Payment

PRACTICE	COMPENSATION	REQUIREMENTS
Emissions Scoring	\$0.05-\$0.07/bu	Beat local benchmark for greenhouse gas emissions on field level basis. Sign a self-declaration document. Premium paid bi-annually on all bushels delivered to Spiritwood, ND ADM location from Sept. 1, 2023-Aug. 31, 2024.
Emissions Scoring	\$0.10-\$0.14/CWT	Beat local benchmark for greenhouse gas emissions on field level basis. Sign a self-declaration document. Premium paid bi-annually on all bushels of Canola delivered to Velva, ND, Enderlin, ND, or ADM Locations taking Canola from Sept. 1, 2023-Aug. 31, 2024.

Additional Wheat Payments

PRACTICE	COMPENSATION	REQUIREMENTS
No-Till or Strip Till	\$2/acre	Only applicable on winter wheat fields planted in 2022 OR spring wheat planted in 2023. Can be in other federally funded programs.
Living Root	\$3/acre	Only applicable on winter wheat fields planted in 2022 OR spring wheat planted in 2023. Can be in other federally funded programs. Not stackable with cover crop payments above. Have a living root established on field year round. (Double cropped soybeans after wheat, cover crop that is harvested)
 Nitrogen Balance	\$5/acre	Only applicable on winter wheat fields planted in 2022 OR spring wheat planted in 2023. Can be in other federally funded programs. Stackable with all payments above. Nitrogen levels must fall within N-Defense safe zone. Scan QR Code for more info.

Requirements for all:

- 1 Must not be part of any private regenerative ag or carbon program on acreage signed up
- 2 Completion of enrollment survey/agreement (5-10 min)
- 3 Completion of data collection with FBN and closing survey (15-45 min)
- 4 A small subset of farmers will be randomly selected and compensated \$1,000 for onsite verification of practices

Data Collection Deadline: December 1, 2023

Payment Date: May 31, 2024
